IETF LLC Transition – Administrative Highlights

- LLC established August 27, 2018
- LLC is up and running!
 - Interim board seated with Chair established
 - Interim Executive Director assigned
 - Finance processes established, operating bank accounts set up/transitioned, review processes with board and ISOC established
 - Support contracts extended and in place, roles and responsibilities with AMS established
 - Templates created and finalizing business process for accepting charitable contributions
 - Contract assignments from ISOC to LLC underway
- Administrative work of the IAOC continues under the LLC

- Thompson Hine: completion of GDPR amendments for contractors
- Finalize plans for registration as foreign entity in CA; update processes and communications/templates
- Prepare for transition of permanent board
- Obtain Commercial General Liability and other appropriate insurance policies, with agreed-upon coverage limits (once permanent board is seated and employment model established)
- Additional priorities to be set as part of our discussions today
- Prepare for various RFP processes (eg. Secretariat, Tools)

Charitable Fundraising Analysis

- Evaluated state and federal laws related to fundraising
- Coordinated with ISOC and external counsel
- Investigated endowment transfer

IETF LLC Transition – CafePress Store

- CafePress store: https://www.cafepress.com/ietf
- In theory, an online IETF store seems like a good idea, and a practical way to make merchandise available around the world. In practice, CafePress has not worked as hoped, for several reasons:
 - Enthusiasm for the idea of an IETF store is not matched by a willingness to pay (e.g., there have been no orders placed in seven years)
 - There are anecdotal reports concerning quality of CafePress goods
 - CafePress lacks flexibility in design options (e.g., sleeve printing is not possible)
 - CafePress is still connected to ISOC's bank accounts (i.e., we would need to manage the transition to LLC financial accounts)
 - We recommend closing the IETF CafePress store instead of pursuing transition to LLC



G-Suite Review



IETF LLC Transition – G-Suite Review

- The IAOC began investigation into an improved content management system for administrative documentation.
- The LLC board accepted the recommendation of G Suite as the best fit
- Overview of IETF G Suite
 - getting started and general "how to"
 - folder structure
 - access levels
 - sharing settings
- Need board discussion/decision about who will get G Suite accounts
 - How often to audit accounts/revisit
