a	A matrix with number of rows equal to the number of observed variables and number of columns equal to the number of latent variables, containing the discrimination parameters for each item and dimension.
b	A list with length equal to the number of observed variables, containing intercept parameters and, if applicable, the scale parameter for each observed variable.
modeltype	A character vector with length equal to the number of observed variables to simulate, indicating which model should be used for each variable. Options are "GPCM", "GRM", "negbin", "normal", and "poisson".
z	The matrix of latent variable values, with rows indicating the individual and the columns indicating the dimension.

Arguments

y	The observed data matrix, with missing values coded as NA. Categorical data must be coded as successive integers starting from 1.
model	A matrix of NAs and 1s, with number of rows equal to the number of observed variables and number of columns equal to the number of latent variables, indicating which observed variables are related to which latent variable.
modeltype	A vector of strings with length equal to the number of observed variables, denoting which model to use for each observed variable. For ordinal data "GPCM" - generalized partial credit model, "GRM" - graded response model (default), for count data "negbin" - negative binomial, "poisson" - poisson, and for continuous data "normal" - normal.
link	A vector of strings with length equal to the number of observed variables, denoting which link function to use for each observed variable. Currently, this function is not active. The default link functions are logit (for "GPCM" and "GRM"), log (for "negbin" and "poisson"), and identity (for "normal").

<code>mi</code>	A vector with the number of categories of each categorical observed variable, where the default is to compute the number of categories automatically from the observed categorical variables.
<code>X</code>	An optional data matrix of numeric covariates, used to estimate latent regression models.
<code>group</code>	A vector indicating the group membership of each individual. The groups should be coded with integers starting from 0. The group denoted by 0 will be considered the reference group and the mean and variance of the latent variables in this group will by default not be estimated.
<code>parequal</code>	A list of seven lists indicating equality restrictions of model parameters. Entry 1 concerns restrictions on the slope parameters, entry 2 restrictions on the intercept parameters, entry 3 restrictions on scale parameters, entry 4 restrictions on regression parameters, entry 5 restrictions on mean parameters, entry 6 restrictions on variance parameters, and entry 7 restrictions on covariance parameters. Restrictions on slope parameters requires specifying which variables and dimension the restriction applies to, while restrictions on intercept and scale parameters only requires specifying which variables the restriction applies to. Restrictions on regression parameters is not yet implemented. Restrictions on variances and covariances requires specifying which covariances should be set equal, where for the variances the order is from the first to the last latent variable as defined by the model specification and where for the covariances the order is determined by the upper triangular part of the covariance matrix of the latent variables (by row). The default is to have no equality restrictions for any parameter, except those set to the same constants.
<code>parfix</code>	A list of lists indicating restrictions of parameters to constants. Entry 1 concerns restrictions on the slope parameters, entry 2 restrictions on the intercept parameters, entry 3 restrictions on scale parameters, entry 4 restrictions on regression parameters, entry 5 restrictions on mean parameters, entry 6 restrictions on variance parameters, and entry 7 restrictions on covariance parameters. Restrictions on slope parameters requires specifying which variables and dimension the restriction applies to and the parameter values, while restrictions on intercept and scale parameters only requires specifying which variables the restriction applies to and the parameter values. Restrictions on regression parameters is not yet implemented. Restrictions on variances and covariances requires specifying which variance and covariances should restricted and to which parameter values, where for the variances the order is from the first to the last latent variable as defined by the model specification and where for the covariances the order is determined by the upper triangular part of the covariance matrix of the latent variables (by row). The default is to have no restrictions on the slope, intercept, scale, regression, and covariance parameters while the means are set to zero and the variances are set to one. See examples for details.
<code>groupequal</code>	A list of lists indicating equality restrictions of parameters across groups. Entry 1 concerns restrictions on the slope parameters, entry 2 restrictions on the intercept parameters, entry 3 restrictions on scale parameters, entry 4 restrictions on regression parameters, entry 5 restrictions on mean parameters, entry 6 restrictions on variance parameters, and entry 7 restrictions on covariance parameters. Restrictions on slope parameters requires specifying which variables,

dimension and groups the restriction applies to, while restrictions on intercept and scale parameters only requires specifying which variables and groups the restriction applies to. Restrictions on regression parameters is not yet implemented. Restrictions on variances and covariances requires specifying which variances and covariances in which groups should be set equal, where for the variances the order is from the first to the last latent variable as defined by the model specification and where for the covariances the order is determined by the upper triangular part of the covariance matrix of the latent variables (by row). The default is to have equality restrictions for all slope, intercept, and scale parameters across all groups, and to have no restrictions on the means, variances and covariance parameters across groups. See examples for details.

sw	A numeric vector of survey weights, with length equal to the number of observations.
method	A string to determine which approximation is used. "lap" - Laplace approximation. "ghq" - Gauss-Hermite quadrature. With more than four latent variables "ghq" becomes too computationally demanding to use and with more than 20 latent variables, second-order Laplace becomes too computationally demanding to use.
accuracy	An integer indicating the accuracy of the approximations used. If the Laplace approximation is used, it indicates the order of the Laplace approximation (first-order (1) and second-order (2) Laplace approximations are supported). If Gauss-Hermite quadrature is used, it indicates the number of quadrature points per latent dimension.
tol	The absolute tolerance between successive iterations to use when estimating the model parameters. Default is 1e-4.
maxit	The maximum number of iterations allowed for the parameter estimation. Default is 500.
optimizer	A character vector denoting which optimization routine to use. Options are "BFGS" (default; quasi-Newton with the BFGS Hessian approximation) and "BHHH" (quasi-Newton with the empirical cross-product Hessian approximation). "BHHH" is the fastest option but has problems converging with small sample sizes ($n < 1000$). "BFGS" is more robust but slower than "BHHH" and may need multiple restarts with different starting values to converge to a local maximum.
obsinfo	A logical argument indicating if the observed information matrix should be calculated after convergence, using numerical differentiation of the approximated observed gradient. (Warning: the calculation is computationally intensive with many model parameters, especially with <code>modeupdate = TRUE</code> .)
resdim	An optional numerical vector indicating which latent variables are to be considered residual variables, for which the covariance parameters should not be estimated.
adapt	A logical argument, indicating whether adaptive Gauss-Hermite quadrature (TRUE; default) or ordinary Gauss-Hermite quadrature (FALSE) is used.
fullexp	A logical argument, indicating whether fully exponential approximation (TRUE; default) or ordinary approximation (FALSE) is used. If <code>method = "ghq"</code> , <code>adapt =</code>

FALSE, and `fullexp = FALSE`, both the numerator and denominator in the gradient is approximated by ordinary Gauss-Hermite quadrature. If `method = "ghq"`, `adapt = TRUE`, and `fullexp = FALSE`, both the numerator and denominator in the gradient is approximated by adaptive Gauss-Hermite quadrature. If `method = "ghq"`, `adapt = TRUE`, and `fullexp = TRUE`, the gradient is approximated by fully exponential Gauss-Hermite quadrature. Further, if `accuracy = 1`, the fully exponential Laplace approximation is used.

<code>z.tol</code>	The relative tolerance to use when estimating the mode of the latent variables. Default is $1e-8$.
<code>maxdiff</code>	The maximum allowed parameter estimate update in each step of the algorithm. To stabilize the algorithm at the initial stage, this argument will limit how much each parameter estimate is allowed to change across successive iterations. Default is 0.25.
<code>step.length</code>	A numeric vector of length two, indicating the step lengths used. The first value is used for the first.step number of iterations and the second value for the remaining iterations. The defaults are 0.5 and 1, respectively.
<code>first.step</code>	The number of iterations which use the step length indicated by the first value of <code>step.length</code> . Default is 25, which means that the first 25 iterations will use the step length equal to the first vector entry in argument <code>step.length</code> and thereafter the second entry in the argument <code>step.length</code> will be used.
<code>inithess</code>	Sets the initial approximation to the Hessian matrix in the BFGS algorithm. Options are "crossprod" (empirical cross-product matrix), "identity" (identity matrix) and "NCW" (p. 142 in Nocedal and Wright (2006)). Default is "NCW". Option "crossprod" is recommended only when informative starting values are available.
<code>startval</code>	An optional vector of starting values for the parameters of the model. Must be equal to the number of uniquely estimated parameters of the model. For NA entries, the default starting values for the corresponding parameters will be used.
<code>startmode</code>	An optional matrix of starting values for the latent variable mode estimation for each individual.
<code>starteval</code>	Option to evaluate the log-likelihood and gradient at the specified starting values. Overrides all other options. Default is FALSE.
<code>checkgrad</code>	A logical argument indicating if the analytical gradient of the approximated observed log-likelihood function should be compared to the numerical gradient (used for testing only). Default it FALSE.
<code>modeupdate</code>	A logical argument indicating if the mode should be estimated when calculating the numerical approximation of the observed information matrix. Default it TRUE.
<code>verbose</code>	A logical argument to specify if detailed diagnostic information should be printed in the console during model initialization and as the algorithm runs. Default is FALSE.
<code>filtering</code>	A character vector indicating the type of filtering that should be used for the second-order Laplace approximation. Currently only the default option "advanced" is available, which uses an algorithm that calculates only the unique higher-order derivatives. The argument has no effect with <code>method = "ghq"</code> .

Value

An S4 object of class 'lamleout' that includes the following slots:

Data	A list containing the supplied data (y, group) and information about the data (N, m).
Estimates	A list with parameter estimates (par, partable), standard errors (separ), mode estimates (map), covariance/information matrices (acov, Amat, Bmat), and various other quantities and objects derived from the parameter estimates (loadings, covmat, mu, modelpars, modelpartsoptC).
Model	A list containing model definitions (model, covstruct, modeltype), constraints (groupequal, parequal, parfix), estimation settings (method, accuracy) and filters.
Optim	A list containing the log-likelihood (loglik, logliki), gradient (grad, gradi), AIC, BIC, parameter estimate history (partrace), gradient history (glltrace), number of iterations (iter), and function call (call).
Timing	A data frame containing timing information of data preparation (prep), estimation (est) and post-estimation computations (se).
